modalities are evidence based including: Child Parent Psychotherapy, Parent-Child Interaction Therapy and Trauma-Focused Cognitive Behavioral Therapy, as well as Protective Parenting Groups: Compassion Workshop, Circle of Security and Nurturing Parenting. Clients are primarily referred by DHS Child Welfare and the court system as well as referrals from community partners and some self-referrals. We also actively collaborate with other community partners to refer clients to additional services, such as specialized services for individual adult mental health, substance abuse, interpersonal violence treatment.

The Tertiary Prevention Program provided services to 841 children and adults during the year ended December 31, 2020.
